The House and Senate have agreed to the amended FY15 budget and Governor Deal signed the bill into law last week. The House Appropriations Committee plans to vote on the FY16 general budget this Wednesday, sending it to the House floor for a vote following the committee's approval.

President G.P. "Bud" Peterson continues to highlight the importance of Georgia Tech's funding requests during his meetings in the State Capitol with Appropriations Committee Chairmen and legislative leaders.

Georgia Tech's strengths help to foster start-up companies in Georgia

The Advanced Technology Development Center (ATDC), managed by Georgia Tech, is the State of Georgia's organization to help technology entrepreneurs launch and build successful companies. ATDC is the oldest, largest, and one of the most successful university-affiliated incubators in the United States. The incubator helps to foster innovation and economic development in Georgia by serving over 500 technology startups with capital activity of over \$200 million last year. Since 1999, ATDC companies have attracted over \$2 billion in investment capital. In FY13, Georgia Tech reallocated



\$1.42 million in Institutional resources to leverage positive momentum and support the strategic expansion of ATDC. Georgia Tech's FY16 request for increased funding for ATDC would help to support new companies in advanced computing. clean energy, and nanotechnology. Increased funding would allow ATDC to hire additional staff dedicated to catalyzing new startup in these strategic industries.
